My name is Elena Mogilyansky. I am a graduate student in biomedical sciences at Thomas Jefferson University (Philadelphia). I am Andrew Mogilyansky' stepmother. I have known Andrew for about 11 years since I got married to his father. During this time I have witnessed a bright, energetic, and intelligent young man with high ambitions to get married, become successful businessman, get involved in politics, organize the foundation for terrorism victims, and recently become a caring father of three young children.

I have witnessed how much respect extended family members, friends, and co-workers have for Andrew. I have seen much older people ask him for advice about everything from stock market to popular vacation spots. I personally always know that I can get his advice, support or just words of encouragement in any situation.

I remember that when he found out that his father and I got engaged while we were on vacation in Europe, he sent us the most beautiful flower arrangement. He wrote on the card that it was one of the happiest days in his life. He was really trying to make me feel welcomed to the family. Later he continued to do everything to make me feel comfortable when our families lived together for 3 years under one roof. I saw how much he adored his little sister Lucy (my and his father's daughter), played with her and spoiled her with new toys whenever he could.

His successful business is not pure luck, but a result of determination, hard work and intelligence. I saw him work long hours, including weekends. However, despite his busy work schedule he always found time to help other people. He got involved in politics and created the foundation to help terrorism victims. I saw him spend long hours in New York participating in political debates, testifying to defend victims of terror or personally having appointments with doctors who agreed to perform free surgeries for kids from Beslan, who become severely disabled after terrorist attacks. Becoming a father has drastically changed Andrew's life. He stopped working on weekends and tried to be home as early as he could to spend time with children before their bed time. All three children love him very much and playing with daddy when he comes home from work is always the highlight of their day.

In conclusion, I hope that my personal observation will help you in your decision. I ask you to please be as lenient with Andrew as possible. If you have any questions or need clarification, I will gladly testify in court as a character witness.
